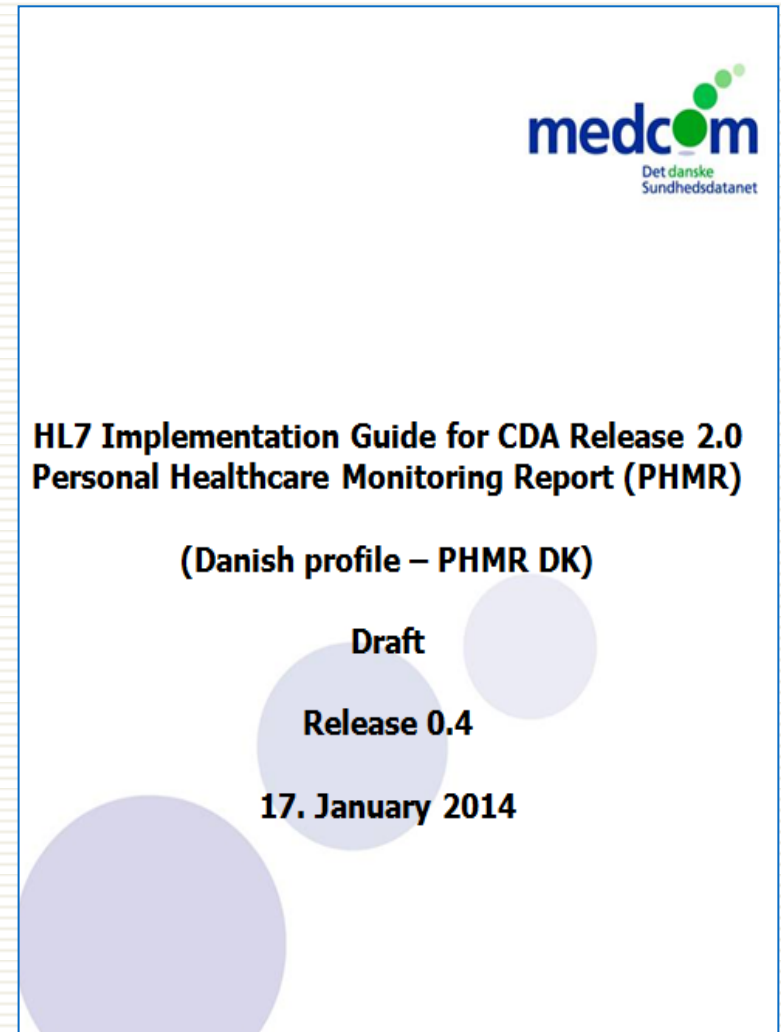

# Approach for the PHMR DK profile

- Consistent with balloted Implementation Guides (IGs) for CDA.
- Constraints
  - CDA itself is a set of constraints on the RIM
  - CCD add constraints to CDA through conformance statements
  - HL7's Personal Healthcare Monitoring Report (PHMR) further constraints and restricts CCD
  - The PHMR DK profile further constraints and restricts PHMR (US Realm)
- Conformance statements
  - CONF-PHMR-X (US Realm)
  - CONF-PHMR-DK-Y (Danish Profile)
